MISSION STATEMENT

PARENT PORTAL

Parent Portal, CPS online student information system, provides a quick and easy way for parents and students to access student grades and attendance information. Parents will need to provide their email address to create an account and ensure access to Parent Portal. The email address will be entered into the system and an account will be created for you. You will receive an email from ASPEN with your account information. You can access parent portal at: https://aspen.cps.edu.

ATTENDANCE

If your child must miss school, you are required to report the absence to the school using one of the following methods:

- Call the school before 9:00 am at (773) 535-8640
- Leave a voicemail message on the school's "Absence Reporting line" (773) 535-8640
- Send an absent note the day your child returns to class
- E-Absence note via Aspen Parent Portal (aspen.cps.edu)

In the interest of your child's safety, Richardson Middle School will contact all homes where there is an unexplained student absence.

All absences require the parent or guardian to notify the school explaining the reason for the absence. This note should be given to the homeroom teacher the day the child returns to class. The Attendance Office will review all reported absences. The following are valid reasons for an absence to be considered "Excused":

- Death in the Immediate Family
- Family Emergency
- Other. Other situation beyond the control of the student
- Religious observance
- Student illness

A letter of notification will be sent to the parents/guardians of those students who accumulate five (5) and ten (10) unexcused absences. If attendance does not show improvement, an appointment with the Principal will be required.

TARDIES

Whenever a student is tardy (after 8:40 A.M.), he or she must receive a <u>Tardy Slip</u> from the Security Desk <u>before</u> reporting to their Homeroom teacher. Students will have a <u>one hour</u> detention after five (5) tardies. Students arriving after 9:30 A.M. will be marked ½ day absent. Parents are asked to <u>please assist us</u> in reinforcing punctuality as an important habit for students to acquire.

EARLY DISMISSALS

Early dismissals affect your child's attendance record and cause significant interruptions to the educational process in the classroom. Therefore, we strongly discourage signing students out for early dismissal unless absolutely necessary. Children who leave more than 60 minutes early will be marked ½ day absent. To avoid the need for an early dismissal, please try to schedule doctor/dental appointments well after dismissal time. However, if you need to take your child home early, you will need to check in at the Security Desk, request your child, and sign your child out. A photo ID is required. The student will be called from class when the parent/guardian arrives at the Security Desk to check them out. There will be no phone requests for early dismissal accepted by the School Office personnel and no requests accepted to have students dismissed between 3:15 and 3:30 PM.

EMERGENCY SCHOOL CLOSINGS/WEATHER CONDITIONS

In the event of extreme weather conditions or any other reason that would require school to be closed CPS (District 299) will officially post that information on the School District website www.cps.edu, notifications will be sent by phone and email and through major news media outlets, such as WGN, WBBM, WMAQ, WLS, WFLD and Univision. You may also check online at www.EmergencyClosingCenter.com under the listing of Public School to find Chicago Public Schools (District 299).

SICK OR INJURED CHILD

ALL injured and sick students will be assessed by the school nurse. Students will be sent back to class or placed in the Care Room based on the nurse's assessment. Parents will be called and informed of their child's status by the school.

*The school must have a phone number, on file, where parents/guardians can be reached at all times.

CONTACT INFORMATION

It is important that an emergency form is on file in the classroom for each child. These forms are issued during the first week of school and should be returned immediately to the teacher. Please list contact information of the closest relatives and friends to be used, in case of an emergency. It is imperative that the teacher be notified immediately of a change of home or work telephone number, email address, home address, or emergency information during the academic school year. The parents or guardians must notify the teacher in writing, so that the office may keep student records updated.

SECURITY

In an effort to provide a safe environment for students, the school is equipped with security cameras and metal detectors. The security cameras are located outside around the perimeter of the school building and inside throughout the building. These cameras operate 24 hours a day and will assist security and the administrative staff in maintaining a safe and secure learning community. The primary goal of the metal detectors is to ensure a safe environment so teachers and students can focus on what matters most in school, teaching and learning. In order to accomplish that goal Richardson's Security will conduct random metal detector searches of students throughout the school year.

HONOR AWARDS

Students will be recognized by their classroom teacher each quarter for honor awards. The school will recognize students who have achieved honors for all 4 quarters in each of the categories at an end of the school year assembly.

PROGRESS REPORTS

The progress report is designed to assess how a child is doing at the midway point of the quarter. Progress reports will be distributed during the sixth week of each marking period:

- September 21, 2023 (Thursday) 1st Quarter
- November 17, 2023 (Friday) 2nd Quarter
- February 8, 2024 (Thursday) 3rd Quarter
- May 3, 2024 (Friday) 4th Quarter

Progress reports give parents the ability to monitor their student's academic progress in meeting the Common Core State Standards.

REPORT CARD PICK-UP

Report Cards are issued every 10 weeks. Parents/Guardians are responsible for picking up the report card from their child's teacher at the end of the 1st and 3rd marking periods. Parent-Teacher conference days are non-attendance days for students.

SCHOOL PROPERTY

Textbooks and Chromebooks are furnished to your child by the school on a loan basis and should be treated as borrowed property. Students must pay for the loss or abuse of textbooks, library books or Chromebooks. Please encourage your child to take good care of both school and personal property.

PERSONAL POSSESSIONS

Students who bring personal possessions to school do so at their own risk. Richardson Middle School is not responsible for the replacement of personal property brought to school that is lost or stolen. This includes clothing, electronic devices, money and other valuable items. There is a lost and found box for clothing located at the Security Desk.

BICYCLES

Students attending Richardson Middle School may ride bicycles to and from school. All bicycles must be properly parked in the racks during the school day by the main entrance, door #1. FOR MAXIMUM SECURITY, STUDENTS MUST ATTACH A LOCK TO THEIR BICYCLE DURING THE

SCHOOL DAY. Students who ride their bicycles to school do so at their own risk, and must comply with the following rules: 1. Bicycle "rules of the road" must be followed. 2. Once the student arrives at school the bicycle must be parked in the designated rack. 3. Students may not ride their bicycles on the school grounds. 4. No bicycles will be allowed in the building.

SCHOOL WELLNESS POLICY

To ensure that all students will be safe in their school building in the fall, CPS will continue to implement evidence-based health and safety protocols. The District has stated that the wearing of masks or cloth face coverings is encouraged but optional.

Students, staff or visitors experiencing cold or flu-like symptoms should remain home until they have been symptom free for at least 24 hours. Richardson Middle School supports lifelong healthy eating habits for all students and staff. We encourage the entire Richardson Middle School community, from staff to parents to students—to engage in a healthy lifestyle through healthy eating behaviors.

Students may bring a bag lunch from home or obtain lunch at school. All students can have breakfast and lunch at no cost, everyday.

All meals served as part of the National School Breakfast and Lunch Programs meet federal, state and local nutrition requirements, as well as CPS Food Service Guidelines. With the goal of displaying healthy eating behaviors, we are designating the following items as being prohibited from being brought into the school for breakfast and lunch: soft drinks, sports drinks, energy drinks or coffee.

No open beverage containers can be brought into school. All water bottles must be unopened coming into the school building. RMS reserves the right to confiscate or prohibit water bottles if they interfere with student learning.

Gum chewing is NOT ALLOWED. Careless disposal of gum in drinking fountains, on furniture and floors present sanitation, and cleaning problems.

The CPS Healthy Snack and Beverage Policy prohibits the use of unhealthy foods for student celebrations or rewards. We are requesting that no sweet treats, such as cupcakes, be brought into school for distribution on a child's birthday or other celebrations. Raisins. banana chips. popcorn, goldfish, snack bars and animal crackers are just a few alternative suggestions that are store purchased items with ingredients listed. Additional ideas can be found www.cps.edu/OSHW Other ways to celebrate special occasions can include exchanging non-food items such as pencils or stickers.

FOOD ALLERGIES:

If your child suffers from food allergies, please provide the school nurse a copy of the diagnosis from your child's pediatrician. Alert your child's teacher of the food allergies as well as the cafeteria. If your child requires juice rather than milk, a doctor's note must be provided for this substitution.

Due to a concern with latex allergies, latex and all other types of balloons are not allowed in school during the school day

POSITIVE BEHAVIORAL INTERVENTIONS and SUPPORTS (PBIS)

What is PBIS? It is a school-wide evidence- based approach for developing positive behavior that is used in schools nationwide. Richardson students are expected to model the B.E.S.T. Expectations (Behave Appropriately, Excel In All You Do, Show Respect, and Treat Others With Kindness). When they do, a staff member may reward their positive behavior with a "Rhino Buck!" "Rhino Bucks" are meant to acknowledge the hard work, commitment, and progress of students as they exhibit positive behavior and responsibility.

Once a month the students are allowed to cash in their "Rhino Bucks" at the Rhino School Store: September/28&29, October/19&20, November/16&17, December/14&15, January/18&19, February/15&16, March/14&15, April/18&19 and May/16&17. Also, at the end of each quarter the students are allowed the opportunity to trade in their "Rhino Bucks" to participate in the "Rhino Rewards Day:" November 3, January 12, April 5, and May 31.

Advancement Via Individual Determination

What is AVID Elementary? The AVID program will teach students to develop the academic habits they will need to be successful in middle school, high school, and college, in an age- appropriate and challenging way. Children learn about organization, study skills, communication, and self-advocacy. AVID students take structured notes and answer and ask high-level questions that go beyond routine answers. The strong college focused culture on an AVID campus encourages students to think about their college and career plans.

CLASS TIME CANNOT BE USED FOR THIS PURPOSE. If you would like to speak with an Administrator, please call the School Office at (773)535-8640 to schedule an appointment. This is the only way to ensure that an Administrator is available to meet with you in order to properly address your concern. All visitors must report to the Security Desk, present a photo ID and sign the visitor's log to obtain a pass. The pass must be worn at all times while in the school or on school grounds.
